
## Farewell to Dennis Dailey

Letter from Rick McLean, Executive Director, BCHA June 6, 2012

This rainy morning in North Carolina is a good time to be inside, working on Back Country Horsemen of America projects. The rain gives me time to think about how proud I am to be part of such a wonderful organization and have the opportunity to meet BCHA members. In the short time I have been your Executive Director, everyone I have met has impressed me with their dedication to the Mission of BCHA. We all share the same passion

for horses, mules, and back country trails. The enthusiasm of the members I meet motivates me to work harder for BCHA.

Under the guidance and direction of the Officers and Executive Committee, my daily work for BCHA focuses on three areas: First, and of primary importance, is our legislative work. As a relative newcomer, my role in the successful effort to get Congressional approval of legislation to restore access to commercial pack stock to the Sequoia-Kings Canyon National Parks was small and insignificant. This is, however, exactly the type of legislative issues I will be working on with our members, Chairman, Vice Chairwoman, board members, staff, and BCHA partners in the future. Over the next several weeks, I will continue the preparation for my first trip to Washington, DC representing BCHA. I will be joining our partners at The Wilderness Society for the Great Outdoors America Week. While in Washington, we will be visiting key contacts in Congress, the National Park Service, the National Forest Service, the Bureau of Land Management, the American Horse Council, and others. One of our goals for this visit is to further our discussions with the public land agencies about uniform rules and certification for the use of crosscut and chainsaws on public lands.

The second area of work is sponsorships and advertising. With the help of our members, I have begun the lengthy process of nurturing old relationships, and establishing new long term, mutually beneficial relationships with sponsors and advertisers interested in BCHA. Our leadership, members, and staff have worked very successfully on this in the past, and as your Executive Director, I hope to build on past efforts and expand opportunities for BCHA. If BCHA is to grow and prosper, we need funding to pay for the business expenses of our organization.

The third area I am working on is growing BCHA membership. To accomplish our Mission of "perpetuating the common sense use and enjoyment of horses in America's back country and wilderness areas" we need members. When we go to Congress, or a public land agency, the more voices (members) we have, the more strength we have. The most effective way to grow our membership is for everyone to share the fun and fellowship of BCHA membership with our friends who ride horses. I believe there are many riders who want to become BCHA members. They just don't know about us yet. To keep BCHA strong into the future, we must recruit new members and teach them about BCHA.

I look forward to working with you as we build the future of BCHA.
